

RESOLUTION NO. 2012-25

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BIGGS RECITING THE FACT OF THE CONSOLIDATED GENERAL ELECTION HELD ON NOVEMBER 6th, 2012, DECLARING THE RESULTS AND SUCH OTHER MATTERS AS PROVIDED BY LAW

WHEREAS, a Consolidated General Election was held and conducted in the City of Biggs, California, on Tuesday, November 6th, 2012, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, pursuant to Resolution No. 2012-04 adopted May 8, 2012, the County Election Department canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as Exhibit "A".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BIGGS, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the number of precincts was 1 and the whole number of votes cast in the precinct was 777.

That the whole number of Times Blank Voted in the City was 27, the whole number of Times Over Voted in the City was 0, the whole Number Of Under Votes in the City was 201, and the whole number of Write-in Votes in the City was 13.

SECTION 2. That the names of persons voted for at the election for Member of the City Council are as follows: Roger L. Frith, John G. Busch, and Mike Bottorff.

SECTION 3. That the number of votes given at the precinct and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates were as listed in Exhibit "A" attached.

SECTION 4. The City Council does declare and determine that: Roger L. Frith was elected as Member of the City Council for the full term of four years; and John G. Busch was elected as Member of the City Council for the full term of four years.

SECTION 5. The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing: (1) The whole number of votes cast in the City; (2) The names of the persons voted for; (3) For what office each person was voted for; (4) The number of votes given at each precinct to each person; (5) The total number of votes given to each person.

SECTION 6. That the City Clerk shall certify to the passage and adoption of this resolution and file same with previously adopted original resolutions. The City Clerk shall also administer, to each person elected, the Oath of Office prescribed by the Constitution of the State of California, and shall have them subscribed to it and file with the City Clerk's office.
