SUBJECT: Authorization to participate in Safe Routes to School program and project.

By Resolution 2017-09 Council is asked to grant authority to the City Administrator to participate in the Safe Routes to School program and the City's approved project.

Background

The City has been awarded an ATP (Cycle 2) Safe Routes to School funding grant in the amount of \$809,000 for a project to add sidewalks in the City of Biggs. This SRTS project is moving forward as Council previously authorized.

Council previously approved Resolution 2017-05 authorizing participation, however, CalTrans rejected that resolution for a current \$30,000 project allocation request because the total project amount listed in the resolution conflicted with the allocation request. The current resolution reflects that change requested by CalTrans.

WHEREAS, the City of Biggs is eligible to receive state and/or federal funding administered by
the California Department of Transportation (Caltrans); and,

WHEREAS, Caltrans has authorized state funds for a Safe Routes to School project to be
undertaken in the City of Biggs and located at B Street from First to Eleventh Street and on
Second Street from E to north of I Streets (Project Number ATPL-5128(011)) (Project); and,

WHEREAS, Caltrans has requested that the City execute various documents regarding said
Project.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BIGGS, CALIFORNIA,
DOES HEREBY RESOLVE AS FOLLOWS:

1. The above recitals are true and correct.
2. The City Administrator is authorized to execute any document upon request by Caltrans
regarding the Project.
3. This resolution shall become effective immediately upon adoption.
