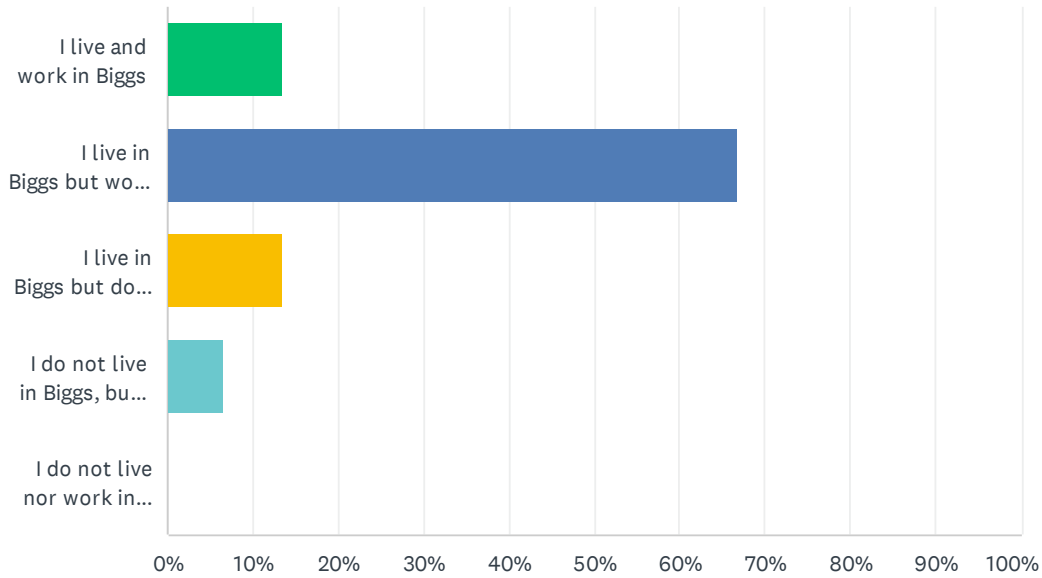


## Q1 Do you live and/or work in Biggs?

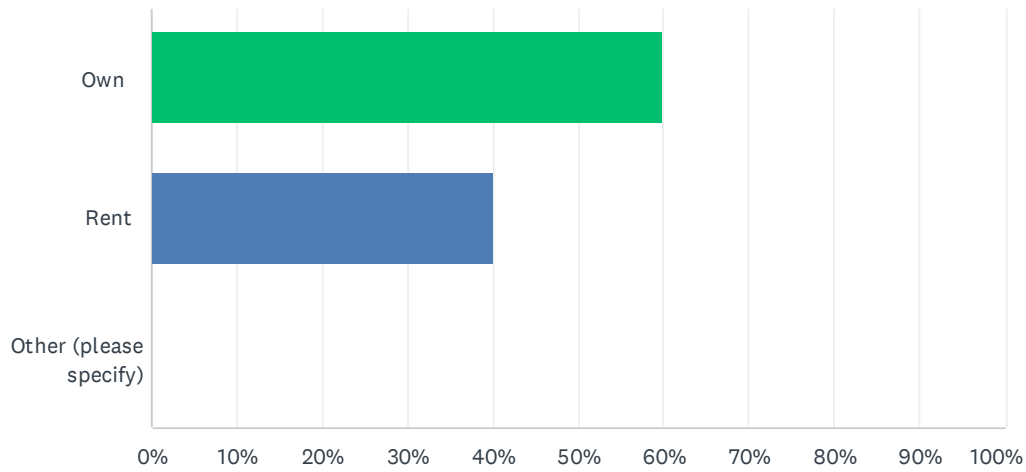

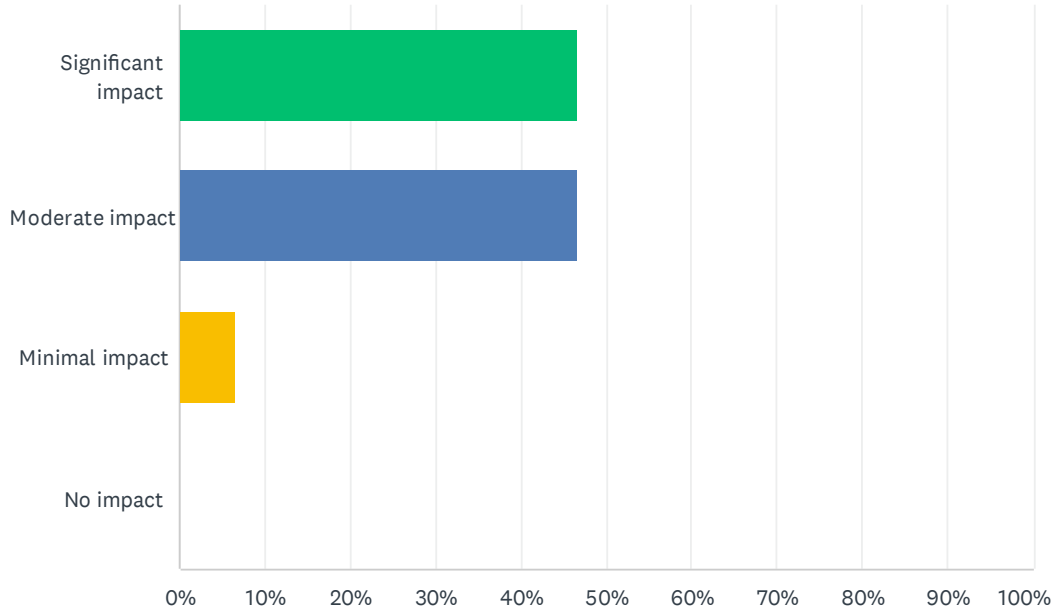

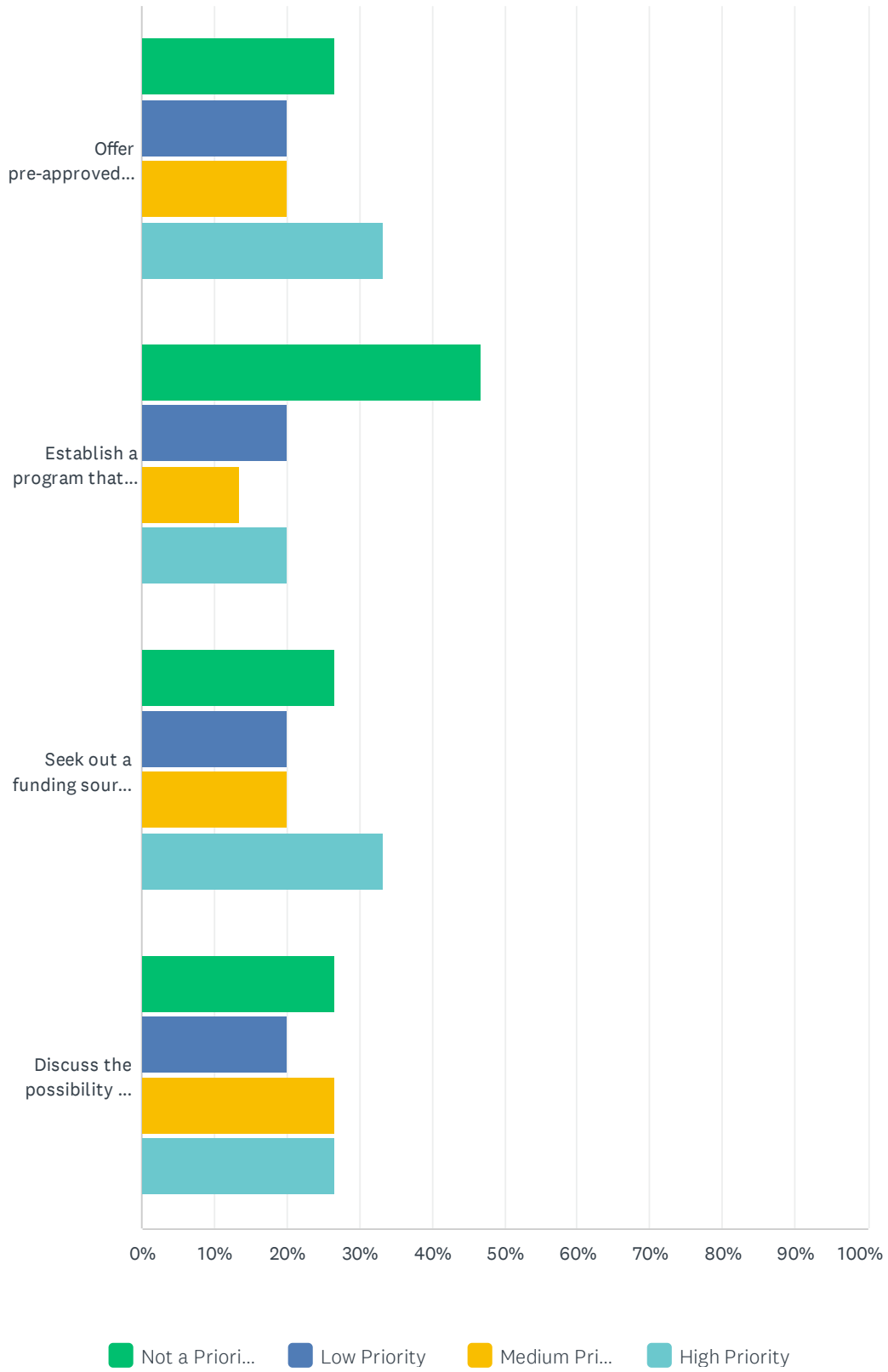
