2. Discussion/Action: First Street Traffic and Street Parking.

First Street, between B Street and Aleut Street, has been widened to the west side with a concrete curb, gutter, and sidewalk. The east side of First Street has not been widened and has no street improvements. The City has posted No Parking along the east side of First Street, but street parking is allowed along the west side.

When vehicles are parked along the west side of First Street it makes the remaining street pavement too narrow for two-way traffic flow.

**Recommendation:** Direct staff on this street traffic item.

The planned ATP/SRTS project sidewalk improvements at the B Street UPRR crossing are on hold pending the UPRR permit approval. UPRR has provided a cost estimate for the required track upgrade work and is requesting approval for the proposed cost-share agreement.
